The Roads Corporation, trading as VicRoads, awards you Contract No. 10088 for asphalt resurfacing of various roads within VicRoads Metro Assets – Eastern Area in accordance with the contract document, including any post tender correspondence, on a lump sum basis for the contract sum of \$9,035,939.67.

Two copies of the Formal Instrument of Agreement and the other documents comprising the contract will be forwarded to you shortly for execution. Under the General Conditions of Contract, you are required to return all these documents, duly executed, to VicRoads, Procurement Services, Ground Floor, 60 Denmark Street, Kew, Vic 3101 within 10 business days of receipt of the documents.

The security of \$451,796.00, being 5% of the contract sum, is to be lodged at Procurement Services, Ground Floor, 60 Denmark Street, Kew, Vic 3101 within 14 days of the date of this letter. The security may be submitted in any of the approved forms referred to in sub-clause 5.3 of the General Conditions of Contract.

Your attention is drawn to Clause 22 of the General Conditions of Contract relating to the inspection of insurance policies. This Contract is awarded on the basis of the Contract being included in the VicRoads Principal Arranged Construction Risks Insurance Policy. It will be necessary for you to produce to the Superintendent prior to commencing work:

- evidence that you are insured or self-insured for the purposes of the *Workplace Injury Rehabilitation and Compensation Act 2013*.

Your attention is also drawn to Schedule 26 – Local Jobs First Policy Non-Strategic Projects with Contestable Items. Notwithstanding the Conditions of Tendering, Schedule 26 has been included in the Contract.

Your attention is also drawn to Schedule 27 – Social Procurement Compliance Schedule. Notwithstanding the Conditions of Tendering, Schedule 27 has been included in the Contract.

The Director – Metro Assets (Roads), VicRoads, 12 Lakeside Drive, Burwood East, Vic 3151 is appointed Superintendent for the Contract.

Contractor's Payment Claims are to be served upon the Superintendent as the VicRoads nominee and the Superintendent will provide Payment Schedules, in accordance with the *Building and Construction Security of Payment Act 2002*, as amended, to the Contractor.

The date of acceptance of tender is **19 DEC 2019**

The time for Practical Completion of the Works is within twenty-six (26) weeks of the date of acceptance of tender.
