The Roads Corporation, trading as VicRoads, awards you Contract No. 9414 for continuous safety barriers works on Princes Highway East, between Bunyip River, Longwarry North and Monash Way, Morwell and on Bass Highway between Westernport Road, Lang Lang, and Anderson Link Road, Anderson in accordance with the contract document, including any post tender correspondence, on a schedule of rates basis for an estimated contract sum of \$16,989,879.40. The contract sum is based on VicRoads estimate of the quantities of work.

Two copies of the Formal Instrument of Agreement and the other documents comprising the contract will be forwarded to you shortly for execution. Under the General Conditions of Contract, you are required to return all these documents, duly executed, to VicRoads, Procurement Services, Ground Floor, 60 Denmark Street, Kew, Vic 3101 within 10 business days of receipt of the documents.

The security of \$849,492.00, being 5% of the contract sum, is to be lodged at Procurement Services, Ground Floor, 60 Denmark Street, Kew, Vic 3101 within 14 days of the date of this letter. The security may be submitted in any of the approved forms referred to in sub-clause 5.3 of the General Conditions of Contract.

Your attention is drawn to Clause 22 of the General Conditions of Contract relating to the inspection of insurance policies. This Contract is awarded on the basis of the Contract being included in the VicRoads Principal Arranged Public Liability Insurance Scheme. It will be necessary for you to produce to the Superintendent prior to commencing work:

- evidence that you are insured or self-insured for the purposes of the *Accident Compensation Act 1985* and the *Accident Compensation (Workcover Insurance) Act 1993*.

The Regional Director – Eastern Victoria, VicRoads, 120 Kay Street, Traralgon, Vic 3844 is appointed Superintendent for the Contract.


