The Head, Transport for Victoria<sup>1</sup>, established under s 64A of the *Transport Integration Act 2010*, awards you Contract No. 9574 for construction of overtaking lanes, pavement rehabilitation and associated road safety works on the Princess Highway West, Weerite in accordance with the contract document, including any post tender correspondence, on a lump sum basis for the contract sum of \$7,945,480.00.

Two copies of the Formal Instrument of Agreement and the other documents comprising the contract will be forwarded to you shortly for execution. Under the General Conditions of Contract, you are required to return all these documents, duly executed, to Department of Transport, Procurement Operations, Ground Floor, 60 Denmark Street, Kew, Vic 3101 within 10 business days of receipt of the documents.

The security of \$397,274.00, being 5% of the contract sum, is to be issued in favour of Head, Transport for Victoria and to be lodged at Procurement Operations, Ground Floor, 60 Denmark Street, Kew, Vic 3101 within 14 days of the date of this letter. The security may be submitted in any of the approved forms referred to in sub-clause 5.3 of the General Conditions of Contract.

Your attention is drawn to Clause 22 of the General Conditions of Contract relating to the inspection of insurance policies. This Contract is awarded on the basis of the Contract being included in the Department of Transport Principal Arranged Construction Risks Insurance Policy. It will be necessary for you to produce to the Superintendent prior to commencing work:

- evidence that you are insured or self-insured for the purposes of the *Workplace Injury Rehabilitation and Compensation Act 2013*.

The Regional Director-South Western Region, Department of Transport, 29 Jamieson Street, Warrnambool Vic 3280 is appointed Superintendent for the Contract.

Contractor's Payment Claims are to be served upon the Superintendent as the department's nominee and the Superintendent will provide Payment Schedules, in accordance with the *Building and Construction Security of Payment Act 2002*, as amended, to the Contractor.

The date of acceptance of tender is **24 FEB 2020**

The time for Practical Completion of the Works is within sixteen (16) weeks of the date of acceptance of tender.
